uploaded on DCI website within 15 days after opening of lockdown by the respective
State/UT/District – Regarding.

Sir/Madam.

I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of all the institution to ensure that no incident of ragging takes place in their dental institution and measures taken to curb it may be reviewed.

- 2. As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case, any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.
- 3. All dental institutions should issue advertisements against ragging through signboards, pamphlets etc. before the commencement of academic year as well as during the midst of the session. You are also requested to issue booklets to all the students of your Institutions containing the details about what constitutes ragging, punishable ingredients of ragging, punishments and penalty for ragging, names and mobile numbers of the members of the Anti Ragging Squad, Anti Ragging Committee (Anti Ragging Helpline), Wardens, Deputy Wardens of Men's and Women's hostel including maintaining social distancing as precautionary measure.
- 4. All dental Institutions shall designate any of their faculty member(s) as "Counsellor" for fresher and senior students to co-ordinate the batches of students (Counselees) regularly about day-to-day problems and also to sensitize their role in curbing the menace of ragging.
- 5. You are further requested to obtain and file undertaking, on antl ragging, from all parents/guardians and students (1st year to final year) studying in BDS/MDS/PG Diploma/Para Dental Courses or any other course approved/recognised by DCI, online through www.antiraqqinq.in / www.amanmovement.org.
- 6. Besides above, it is also pertinent to mentioned here that, as per section 12.2 of subject regulations, each and every institution shall submit its reports in prescribed format (Annexure-II) to the Secretary, Dental Council of India, Aiwan-E-Galib Marg, Kotla Road, New Delhi-110002, by 30th April of every year in respect of the previous academic session, indicating the requisite information against each column thereof, failing which the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:-

- To initiate the derecognition process against the institution under section 16A of the 11.4.1 Dentists Act, 1948.
- To reduce the admission capacity of the institution to the extent to which the Council 11.4.2 deem fit.
- To stop further admission in the institution till further orders: 11,4.3
- To stop renewal of permission in respect of UG/PG Dental Courses. 11.4.4
- To post the information regarding penalties so imposed on the concerned institution 11.4.6 on the website of DCI for information of all concerned.

- In view of the above, I am directed to request you that the requisite information for the previous academic session 2019-2020 may kindly be uploaded on DCI website within 15 days of the opening of lockdown in the respective State/UT/District, positively, as the said information is required to be sent to the Monitoring Committee appointed by the Hon'ble Supreme Court of India. In case the information is not uploaded within abovementioned duration, the name of defaulting institution will be forwarded to the said Monitoring Committee for such appropriate action as may be deemed fit and proper by the said Hon'ble Monitoring Committee, and their names will also be uploaded on DCI Website.
- This may kindly be treated as 'Most Urgent'. 10.
- The Dental Council of India ensures Zero Tolerance against ragging of any sort. 11.







MEASURES FOR CURBING THE MENACE OF RAGGING IN EDUCATIONAL INSTITUTIONS -IMPLEMENTATION OF DIRECTIONS OF HON'BLE SUPREME COURT OF INDIA - information as per section 12.1 of DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009 to be uploaded on DCI website by 31.10.2019 - Regarding.

Sir/Madam.

I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of all the institution to ensure that no incident of ragging takes place in their dental institution and measures taken to curb it may be reviewed.

- 2. As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.
- All dental institutions should issue advertisements against ragging through signboards, pamphlets etc. before the commencement of academic year as well as during the midst of the session. You are also requested to issue booklets to all the students of your Institutions containing the details about what constitutes ragging, punishable ingredients of ragging, punishments and penalty for ragging, names and mobile numbers of the members of the Anti Ragging Squad, Anti Ragging Committee (Anti Ragging Helpline), Wardens, Deputy Wardens of Men's and Women's hostel.
 - All dental Institutions shall designate any of their faculty member(s) as "Counsellor" for fresher and 4. senior students to co-ordinate the batches of students (Counselees) regularly about day-to-day problems and also to sensitize their role in curbing the menace of ragging.
 - You are further requested to obtain and file undertaking, on anti ragging, from all parents/guardians 5. and students (1st year to final year) studying in BDS/MDS/PG Diploma/Para Dental Courses or any other course approved/recognised by DCI, online through www.antiragging.in / www.amanmovement.org.
 - Besides above, it is also pertinent to mentioned here that, as per section 12.1 of subject regulations, each and every institution shall submit its reports in prescribed format (Annexure-II) to the 6. Secretary, Dental Council of India, Aiwan-E-Galib Marg, Kotla Road, New Delhi-110002, by 31 October of every year in respect of the previous academic session, indicating the requisite information against each column thereof, failing which the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:-
 - To initiate the derecognition process against the institution under section 16A of 11.4.1 the Dentists Act, 1948.
 - To reduce the ad mission capacity of the institution to the extent to which the 11.4.2 Council deem fit.
 - To stop further admission in the institution till further orders. 11.4.3
 - To stop renewal of permission in respect of UG/PG Dental Courses. 11.4.4 To post the information regarding penalties so imposed on the concerned
 - 11.4.6 institution on the website of DCI for information of all concerned

- 7. Further, it is also to inform you that the DCI has developed an online module to upload the requisite information / documents on DCI website to reduce the paper work and to scrutiny the above data efficiently, decided that the all the requisite information / documents required as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall be uploaded on DCI website and any hard copy of information / documents received by Post or sent by E-mail shall not be considered by DCI.
- 8. In view of the above, I am directed to request you that the requisite information in the prescribed format (Annexure-II as prescribed in DCI Regulations) for the <u>academic session 2019-2020</u> may kindly be uploaded on DCI website <u>by 31.10.2019</u>, positively, as the said information is required to be uploaded as per request of the Monitoring Committee appointed by the Hon'ble Supreme Court of India. In case the information is not uploaded <u>by 31.10.2019</u> on DCI website, the name of defaulting institution will be forwarded to the said Monitoring Committee for such appropriate action as may be deemed fit and proper by the said Hon'ble Monitoring Committee, and their names will also be uploaded on DCI Website.

No.1-15/2009 (ARC) pt.III dated 27.06.2019, in order to ensure a ragging free campus, has made the following recommendations and action steps to be deployed at all the institutions including dental colleges:-

A. Basic Measures:

- Constitution of anti-ragging committee, anti-ragging squad, setting up of Anti-Ragging Cell and Adequate publicity for these measures through various media are to be undertaken.
- Mention of anti-ragging warning in the institution's prospectus and information booklets/brochures shall be ensured.
- Updating websites of institutions with the complete address and contact details of nodal officers related to anti-ragging committee.
- In compliance with the UGC Regulations and its 2nd Amendment regarding submission of undertaking by each student and every parent, an online undertaking in every academic year to be submitted.
 - UGC has notified 3rd Amendment in UGC Regulations on 29th June, 2016 to expand the definition of ragging by including the following:
 - "3. (i) Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality,

D. Using other UGC initiated measures

- Students in distress due to ragging related incidents can call the National Anti-Ragging Helpline 1800-180-5522 (24x7 Toll Free) or e-mail the Anti-Ragging Helpline at helpline@antiragging.in.
- 2. For any other information regarding ragging, please visit the UGC website i.e. www.uqc.ac.in & www.antiragging.in and contact UGC monitoring agency i.e. Aman Satya Kachroo Trust on mobile No. 09871170303, 9818400116 (only in case of emergency).
- UGC also drives an Anti-Ragging Media Campaign through different modes and UGC has got developed the following entities to promote anti-ragging which are available on UGC website i.e. <u>www.uqc.ac.in</u>.
- a. UGC has developed 05 TVCs of 30 seconds each from different perspective i.e. parents, Victim and Offenders.
- b. UGC has designed and distributed posters amongst Universities/Regulatory Authorities/Councils/IITs/NITs/Other educational institutions for the prominent display.
- c. UGC has consecutively organized 02 Anti-Ragging Competitions for students/faculty /general public for the wider awareness of the menace of ragging.

Besides, each and every dental institution shall be statutorily obliged to conduct an Anti-Ragging workshop immediately after the admission process at both UG and PG level and all UG / PG students of the college and all member of the Anti-ragging committee shall attend such workshop. Further, Anti-ragging workshop shall not be included with any other conference / programme and activities of the college.

Accordingly, each and every dental institutions including your dental college are requested to implement the recommendations contained in their earlier communication of even number dated 27.12.2018 so as to ensure a ragging-free campus, a fundamental requirement for a supportive and fair institutional climate which is open to change, learning and progress.

I am directed to refer to the subject cited above and to say that the last date upto which the students can be joined in BDS Course is 15th September, 2019 as per Time Schedule for completion of admission process for first BDS Course for the academic session 2019-20 as prescribed in "Dental Council of India (Establishment of New Dental Colleges, Opening of New or Higher Course of study or Training and Increase of Admission Capacity in Dental Colleges) (13th Amendment) Regulations, 2018".

- Accordingly, the college authorities of all dental colleges are hereby directed to upload the details of students, admitted in BDS Course at their dental institution for the academic session 2019-2020, on DCI Website, using their already allotted login credentials, on or before the last date of admission i.e. 15th September, 2019, positively, failing which it shall be presumed that the college authorities have not admitted any student in BDS Course at their college for the academic session 2019-20 and if the college authorities claims any admission after the cut-off date, then Section 10B of the Dentists (Amendment) Act, 1993 and Section 16A of the Dentists Act, 1948 shall be attracted.

MEASURES FOR CURBING THE MENACE OF RAGGING IN EDUCATIONAL INSTITUTIONS -IMPLEMENTATION OF DIRECTIONS OF HON'BLE SUPREME COURT OF INDIA - information as per section 121 of DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009 to be uploaded on DCI website by 31.10.2019 - Regarding.

Sir/Madam,

I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of all the institution to ensure that no incident of ragging takes place in their dental institution and measures taken to curb it may be reviewed.

- As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.
- All dental institutions should issue advertisements against ragging through signboards, pamphlets etc. before the commencement of academic year as well as during the midst of the session. You are also requested to issue booklets to all the students of your Institutions containing the details about what constitutes ragging, punishable ingredients of ragging, punishments and penalty for ragging, names and mobile numbers of the members of the Anti Ragging Squad, Anti Ragging Committee (Anti Ragging Helpline), Wardens, Deputy Wardens of Men's and Women's hostel.
- All dental Institutions shall designate any of their faculty member(s) as "Counsellor" for fresher and senior students to co-ordinate the batches of students (Counselees) regularly about day-to-day problems and also to sensitize their role in curbing the menace of ragging.
- You are further requested to obtain and file undertaking, on anti ragging, from all parents/guardians and students (1st year to final year) studying in BDS/MDS/PG Diploma/Para Dental Courses or any other course approved/recognised by DCI, online through www.antiragging.in / www.amanmovement.org.
- Besides above, it is also pertinent to mentioned here that, as per section 12.1 of subject regulations, each and every institution shall submit its reports in prescribed format (Annexure-II) to the Secretary, Dental Council of India, Aiwan-E-Galib Marg, Kotla Road, New Delhi-110002, by 31st October of every year in respect of the previous academic session, indicating the requisite information against each column thereof, failing which the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:-
 - To initiate the derecognition process against the institution under section 16A of

Further, it is also to inform you that the DCI has developed an online module to upload the requisite information / documents on DCI website to reduce the paper work and to scrutiny the above data efficiently, decided that the all the requisite information / documents required as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall be uploaded on DCI website and any hard copy of information / documents received by Post or sent by E-mail shall not be considered by DCI.
- 8. In view of the above, I am directed to request you that the requisite information in the prescribed format (Annexure-II as prescribed in DCI Regulations) for the <u>academic session 2019-2020</u> may kindly be uploaded on DCI website <u>by 31.10.2019</u>, positively, as the said information is required to be uploaded as per request of the Monitoring Committee appointed by the Hon'ble Supreme Court of India. In case the information is not uploaded <u>by 31.10.2019</u> on DCI website, the name of defaulting institution will be forwarded to the said Monitoring Committee for such appropriate action as may be deemed fit and proper by the said Hon'ble Monitoring Committee, and their names will also be uploaded on DCI Website.

Sir/Madam.

I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of all the institution to ensure that no incident of ragging takes place in their dental institution and measures taken to curb it may be reviewed.

- As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.
- All dental institutions should issue advertisements against ragging through signboards, pamphlets etc. before the commencement of academic year as well as during the midst of the session. You are also requested to issue booklets to all the students of your Institutions containing the details about what constitutes ragging, punishable ingredients of ragging, punishments and penalty for ragging, names and mobile numbers of the members of the Anti Ragging Squad, Anti Ragging Committee (Anti Ragging Helpline), Wardens, Deputy Wardens of Men's and Women's hostel.
- All dental Institutions shall designate any of their faculty member(s) as "Counsellor" for fresher and senior students to co-ordinate the batches of students (Counselees) regularly about day-to-day problems and also to sensitize their role in curbing the menace of ragging.
- You are further requested to obtain and file undertaking, on anti ragging, from all parents/guardians and students (1st year to final year) studying in BDS/MDS/PG Diploma/Para Dental Courses or any other course approved/recognised by DCI, online through www.antiragging.in / www.amanmovement.org.
- Besides above, it is also pertinent to mentioned here that, as per section 12.1 of subject regulations each and every institution shall submit its reports in prescribed format (Annexure-II) to the Secretary, Dental Council of India, Aiwan-E-Galib Marg, Kotla Road, New Deihi-110002, by 30 April of every year in respect of the previous academic session, indicating the requisite information against each column thereof, failing which the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:-



Sir/Madam,

I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of all the institution to ensure that no incident of ragging takes place in their dental institution and measures taken to curb it may be reviewed.

- As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.
- All dental institutions should issue advertisements against ragging through signboards, pamphlets etc. before the commencement of academic year as well as during the midst of the session. You are also requested to issue booklets to all the students of your Institutions containing the details about what constitutes ragging, punishable ingredients of ragging, punishments and penalty for ragging, names and mobile numbers of the members of the Anti Ragging Squad, Anti Ragging Committee (Anti Ragging Helpline), Wardens, Deputy Wardens of Men's and Women's hostel.
- All dental Institutions shall designate any of their faculty member(s) as "Counsellor" for fresher and senior students to co-ordinate the batches of students (Counselees) regularly about day-to-day problems and also to sensitize their role in curbing the menace of ragging.
- You are further requested to obtain and file undertaking, on anti ragging, from all parents/quardians and students (1st year to final year) studying in BDS/MDS/PG Diploma/Para Dental Courses or any other course approved/recognised by DCI, online through www.antiragging.in/www.amanmovement.org.
- Besides above, it is also pertinent to mentioned here that, as per section 12.1 of subject regulations, each and every institution shall submit its reports in prescribed format (Annexure-II) to the Secretary, Dental Council of India, Aiwan-E-Galib Marg, Kolla Road, New Delhi-110002, by 31st October of every year in respect of the previous academic session, indicating the requisite information against each column thereof, failing which the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:-
 - To initiate the derecognition process against the institution under section 16A of the Dentists Act, 1948.
 - To reduce the ad mission capacity of the institution to the extent to which the 11.4.2
 - To stop further admission in the institution till further orders. 11.4.3
 - To stop renewal of permission in respect of UG/PG Dental Courses. 11.4.4
 - To post the information regarding penalties so imposed on the concerned institution on the website of DCI for information of all concerned. 11.4.6

Further, it is also to inform you that the DCI has developed an online module to upload the requisite information / documents on DCI website to reduce the paper work and to scrutiny the above data efficiently, decided that the all the requisite information / documents required as per DCI Regulations on Curbing the Copy of Information / documents required as per DCI Regulations on Curbing the copy of Information / documents received by Post or sent by E-mail shall not be considered by DCI.
- 8. In view of the above, I am directed to request you that the requisite information in the prescribed format (Annexure-II as prescribed in DCI Regulations) for the <u>previous academic session 2017-2018</u> may to the Monitoring Committee appointed by the Hon'ble Supreme Court of India. In case the information is most uploaded by 31.10.2018 on DCI website, the name of defaulting institution will be forwarded to the said Monitoring Committee, and their names will also be uploaded on DCI Website.

- The Dental Council of India ensures <u>Zero Tolerance</u> against ragging of any sort.
