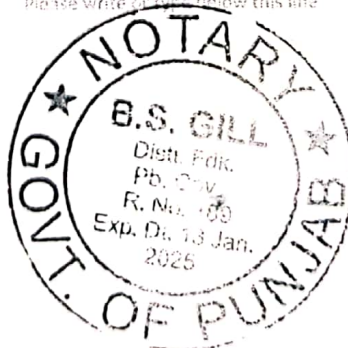

### 1. SCOPE OF SERVICES

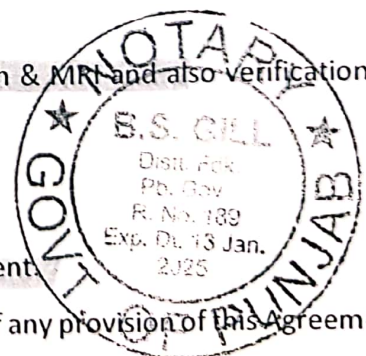
The Service Provider shall provide services in imaging tests namely CT scan & MRI and also verification of imaging results as a part of peer review.

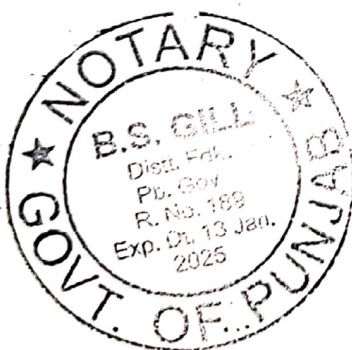
