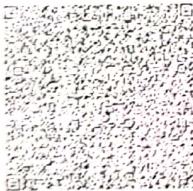

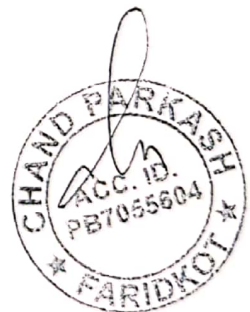
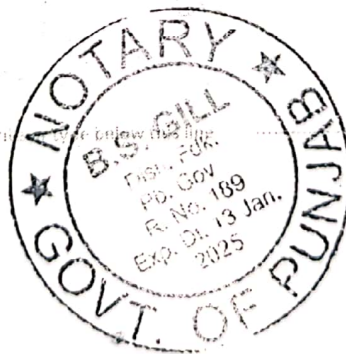

MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding (MOU) is entered into at Faridkot on this 1st day of APRIL (Month) 2024 (Year) Between :

1. **DEEP BLOOD CENTRE FARIDKOT** of Situated at Near Police Station Sadar, Kotkapura Road, Faridkot-151203 represented by its Chairman (here in after referred to as THE PARTIES OF THE FIRST PART).

AND

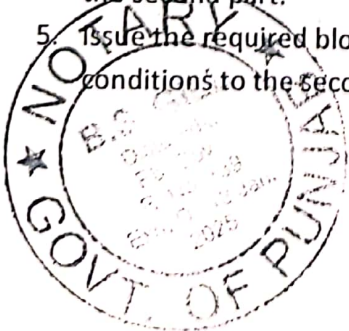
2. **DASMESH HOSPITAL, TALWANDI ROAD, FARIDKOT-151203** represented by its Managing Director (hereinafter referred to as THE PARTIES OF THE SECOND PART).

Whereas the parties of the second part (**DASMESH HOSPITAL, TALWANDI ROAD, FARIDKOT-151203**) desire to avail the Blood Transfusion Services of the parties of the first part (Life Line Blood Centre) in order to make blood / blood Components, available for the management of its patients. The parties of the first part, working on NO profit No Loss basis in the service of the poor and the needy patients desires to assist the parties of the Second part by providing required blood and blood components to the patients admitted in Dasmesh Hospital, Talwandi Road, Faridkot-151203.

Clause 1: This MOU will be initially valid for a period of one year from the date of its execution.

Clause 2: Where as the parties of the first part undertake to:

1. Supply blood and blood components (Whole Blood, Packed Red Cells, Random Donor Platelets, Fresh Frozen Plasma, Cryoprecipitate, Cryo Poor Plasma and Apheresis or Single Donor Platelets). The blood components supplied under this MOU shall satisfy all applicable statutory requirements as per the Drops and cosmetics Act and Rules.
2. The Charges payable by the parties of second part to the parties of the first part shall be as per the rates published by the Punjab state Blood Transfusion Council/National Blood Transfusion Council from time to time.
3. For any extra and specific requirement like leukoreduced Packed Red Cells, extra charge will be charged.
4. The blood units will be supplied on credit basis as per the requirement projected by the parties of the second part.
5. Issue the required blood and blood components under appropriate temperature and storage conditions to the second part, on mutually agreed terms and conditions.



6. Make available on specific request, single donor (Apheresis) Platelets, on providing suitable Platelet Donors at the location of the parties of the first part.
7. Upon request, draw blood from autologous donor's fitness for donation.
8. Provide the details of all blood units supplied and charges applicable thereof and total credit bill to the location of the parties of the second part, fortnightly.

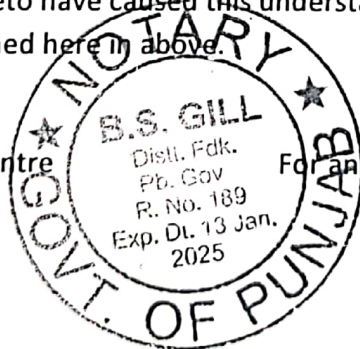
Clause 3: Whereas the parties of the second part undertake to:

1. Receive blood/blood components as per their requirement.
2. Collect requested blood / blood components from the location of the parties of the first part.
3. For any extra and specific requirement like leukoreduced Packed Red Cells, Random Donor Platelets special request will be sent in time for preparation and processing of the same.
4. Make full payment of the amount due by a cheque drawn in favor of Life Care Society, Patiala (Reqd.)" within 15 days of receipt of the credit bill.
5. Motivate friends and relatives of patients to voluntarily donate blood at the blood bank as and when required.

Dispute resolution: All or any disputes between the parties on the interpretation or implementation of this MOU shall be settled by an means of an arbitration of a mutually agreed sole arbitrator in accordance with Arbitration and Conciliation Act 1996.

Conditions of License

1. The licensee shall neither collect blood from any professional donor or paid donor nor shall he prepare blood components from the blood collected from such a donor.
2. The license and any certificate of renewal in force shall be displayed on the approved premises and the original shall be produced at the request of an Inspector appointed under the Drugs & Cosmetics Act, 1940.
3. Any change in the technical staff shall be forthwith reported to the licensing authority and/or Central License Approving Authority.
4. The licensee shall inform the Licensing Authority and/or Central License Approving Authority in writing in the event of any change in the constitution of the firm operating under the license. Where any change in the constitution of the firm takes place, the current license shall be deemed to be valid for maximum period of three months from the date on which the change has taken place unless, in the mean time a fresh license has been taken from the Licensing Authority and/or Central License Approving Authority in the name of the firm with the changed constitution.
