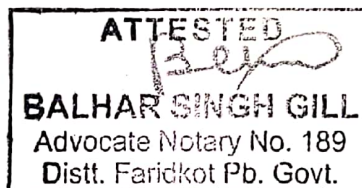
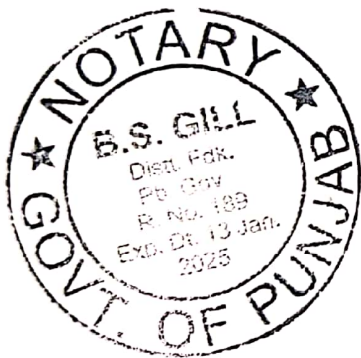
This MOU will commence on 1<sup>st</sup> April, 2024 And will dissolve at the end of 1<sup>st</sup> April, 2026.

### RULES & RESPONSIBILITIES:

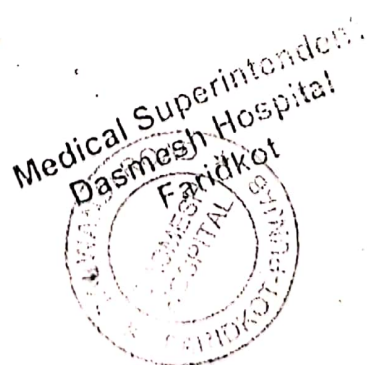
- The Contractor shall provide and pay for all administration, insurance, pharmacist.

- This agreement will be valid for two years from the date of agreement.



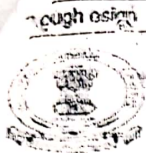
